Each one discussed the areas they would be working on during the General Assembly and the importance of passing a budget and the state pension.

Ms. Virginia Gray, TVA, reported that TVA is working closely with the Energy Cabinet and Economic Development Cabinet to enhance the partnership with each one.

### STAFF:

**Ms. Brittany Fisher,** Transportation Planner, reported the Kentucky Transportation Cabinet's Rural Consultation survey will be closing in a couple of days. Ms. Virginia Stokes, Aging Department, reported on November 20, 2015, BRADD/AAAIL staff was honored to have Congressman Brett Guthrie here at the BRADD Office where he held a round table discussion with the AAAILS and their staff and representatives from his district regarding the Older Americans Act Reauthorization and upcoming changes. AAAILs discussed how the changes impacted the programs for the seniors and caregivers. Congressman Guthrie expressed how beneficial these discussions were to him in regard to his continued work on the Older Americans Act. Request for Proposals for frozen and shelf stable home delivered meals, personal care attendant, and senior center services will be available to be picked up for potential applicants on Friday, December 18, 2015. BRADD/AAAIL staff will make these RFP applications available on the BRADD website on this date as well as www.bradd.org.

Ms. Terryn Varney, Public Administration Specialist, reported the "Understanding Open Meetings, Open Records, and Records Management: What you don't know, CAN hurt you" was held at the BRADD Office on Tuesday, December 1. The morning session was dedicated to Amye Bensenhaver, Assistant Attorney General, discussing open meetings and open records laws. The afternoon session hosted Trace Kirkwood and Kris Justus from the Kentucky Department for Library and Archives, who discussed Records Management (including email management). The BRADD was a pilot site for this training as it is hped to be offered to the remaining ADD's in 2016. We feel it was a success and will soon be gearing up for more training opportunities int he future. Green River Valley Water District (GRVWD) plans to expand its existing Water Treatment Plant (WTP) from 6.0 to 8.0 million gallons per day (mgd). The proposed project includes;

- improvements at the existing River Intake Structure
- New Chemical Feed Equipment and Facilities
- Additional Flocculation, Sedimentation, and Filtration Facilities
- New 1.0 Million Gallon Clearwell and High Service Pumps
- Project also include 200 LF of transmission line from pump station to existing transmission line running parallel to road
- All improvements to be constructed on the existing site.
